## **Award Entry Criteria**

Award assessment is by written entry form submission and evidence, which will be assessed by an impartial Award Judging Panel. Entrants will be accepted up to midnight on the 17 July 2023 with the final announcement taking place on the 1 August 2023.

## **Award Judging Process**

The Registered Trainer of the Year Award has been accredited with the Awards Trust Mark demonstrating our commitment for complete transparency and fairness.

- All entries submitted will be presented to the Awards team.
- The Awards team will check all entries to ensure they are eligible.
- The Awards team will collate written entry submissions and supporting evidence for the judging phase.
- All eligible entries will be presented to the Award Judging Panel 10 days prior to the Judging Day for an initial review.
- Each Judge will use their knowledge and expertise to impartially assess and score each entry.
- The Judging Day allows all Judges to have the opportunity to meet, present and discuss their scores and recommendations.
- At the end of the Judging Day, successful entrants will be selected into four stages; special mentions; shortlisted; finalists and a winner will be chosen.
- If all Judges are unable to agree and determine an overall winner, the Chair of the Award Judging Panel will make the final decision.
- The Winner will be announced during the Awards ceremony.
