



# The Registered Trainer of the Year Award Terms & Conditions

## 1. Eligibility

- 1.1 Exclusively for Trainer Courses Ltd Registered Trainers who have a minimum of one trainer registrations and certifications in date is eligible to enter for the Registered Trainer of the Year Award.
- 1.2 It is the responsibility of the entrant to ensure that their entry submitted satisfy the entry criteria. The organisers reserve the right to reject any submission that, in their opinion, fails to comply with the entry criteria.
- 1.3 Entries open on the stated opening date, and close on the stated closing date. Any entries submitted outside of this period will not be considered.
- 1.4 The organisers reserve the right to reject an entry, if in their opinion; it fails to comply with the rules and conditions.

## 2. Entry Submissions

- 2.1 Submissions for the Registered Trainer of the Year Award will only be accepted via the online entry form on this website ([www.trainercourses.com](http://www.trainercourses.com)).
- 2.2 Entries submitted via post, email or telephone will not be considered.
- 2.3 Entrants may only submit one entry. If the organisers receive more than one entry from a single entrant, then the Awards team will only consider the first entry submitted.
- 2.4 Entries are limited to 1000 words. The organisations reserve the right to reject all entries that exceed the stated word limit.
- 2.5 All entries permit that material submitted by them through the entry process is not false, offensive, defamatory, threatening, obscene or unlawful. Submission of any such material or any inaccurate or misleading material is prohibited.



- 2.6 Entrants shall only submit material which they have personally created unless specific consent has been obtained from the original creator of the material. Where an entrant wishes to submit material they have themselves personally created in the course of employment, permission to do so must be obtained from the relevant employer. The submission of any entry which includes trademarks, logos, designs or databases, or any photographs, images or drawings in which third party copyright may subsist, or anything else in respect of which a third party may claim ownership, is prohibited, unless specific consent for use has been obtained from the owning third party. Entrants permit that no copyright, trade mark or other intellectual property right is infringed by the submission of any material by them, and by agreeing to these Terms and Conditions entrants permit that all necessary consents have been obtained in relation to the publication of all material.
- 2.7 By submitting content through the entry process, entrants grant permission for any reproduction on this website ([www.trainercourses.com](http://www.trainercourses.com)) and in any related marketing collateral used to promote the Registered Trainer of the Year Award, and any other business activities of the organiser Trainer Courses Ltd.
